1 **SECTION 1. FEASIBILITY STUDY AND REPORT ON CON-**
2 **STRUCTION OF FACILITIES OF COVERED**
3 **MULTI-UNITY MILITARY HOUSING AND PAR-**
4 **TIAL USE AS MILITARY CHILD DEVELOPMENT**
5 **CENTER.**

6 (a) FEASIBILITY STUDY AND REPORT.—

7 (1) STUDY.—The Secretaries of the military de-
8 partments concerned shall conduct a feasibility
9 study on—

10 (A) the construction of one or more facili-
11 ties of covered multi-unit military housing in
12 military housing areas specified in subsection
13 (b); and

14 (B) the partial use of a facility of covered
15 multi-unit military housing in a military hous-
16 ing area specified in such subsection as a mili-
17 tary child development center.

18 (2) REPORT.—Not later than 120 days after
19 the date of the enactment of this Act, the Secre-
20 taries of the military departments concerned shall
21 submit to the Committees on Armed Services of the
22 House of Representatives and the Senate a report
23 that includes a summary of the findings of such
24 study.

25 (b) MILITARY HOUSING AREAS SPECIFIED.—The
26 military housing areas specified in this subsection are mili-

1 tary housing areas for which the applicable rates of basic
2 allowance for housing under section 403 of title 37, United
3 States Code, are, on the date of the enactment of this Act,
4 among the highest twenty-five percent of such applicable
5 rates for all military housing areas located in the conti-
6 nental United States.

7 (c) DEFINITIONS.—In this section:

8 (1) The term “covered multi-unit military hous-
9 ing” means housing that is—

10 (A) not Government-owned or Government-
11 controlled;

12 (B) provided under subchapter IV of chap-
13 ter 169 of title 10, United States Code; and

14 (C) contains more than one individual unit
15 of housing.

16 (2) The term “military child development cen-
17 ter” has the meaning given such term in section
18 1800 of such title.
